Who is MO-AG?

MO-AG is an association that caters to the needs of Missouri agribusiness by going to the capitol to protect their interests, providing educational programs, creating a networking environment and sending newsletters to keep members informed of regulations and laws.

Why join MO-AG?

Although there are many reasons to join MO-AG, the most popular ones are the legislative representation, regulatory assistance, networking opportunities and news distribution.

What does it cost?

Manufacturer/Processor/Merchandiser – Dues: \$2,100 plus \$50 for each representative over 10
One whose primary function is the manufacturing, processing, or merchandising of food, fiber, grain, feed, seed, fertilizer, chemicals, equipment, forestry products, livestock, mining of minerals, or related agricultural products across the U.S. and Internationally. Also, one who is engaged in the sale of agricultural related products for resale.

Regional Manufacturer/Processor/Merchandiser – Dues: \$945 plus \$50 for each rep. over 3
Same as above only operations are limited to Missouri and surrounding states.

Distributor – Dues: \$945 plus \$50 for each representative over 3
One who is engaged in the distribution of food, fiber, grain, feed, seed, fertilizer, chemicals, equipment, forestry products, livestock, mined minerals, or related agricultural products.

Service – Dues: \$315 plus \$50 for each additional representative
One whose business is such that it has mutual interest in, but not directly engaged in, the manufacturing, processing, merchandising, marketing, or distribution of food, fiber, grain, feed, seed, fertilizer, chemicals, equipment, forestry products, livestock, mined minerals, or related agricultural products.

Senior Associate – Dues: \$150
Previous member currently retired and not activity engaged in business activity.

Retail – *One who is engaged in the sale of agricultural products to users or consumers at retail. Dues are based on the number of year-round, staffed branch locations. See dues schedule below:*
